Assuming continued employment, the restricted stock units held by the Reporting Person will vest and (4) be paid out as follows: 5,940 on November 1, 2010, 8,194 on October 31, 2011, 4,375 on October 31, 2012 and 2,348 on October 31, 2013, or in each case the first day thereafter that shares may be sold pursuant to company policy. Upon payout, shares will be withheld to cover minimum statutory tax obligations. Restricted stock units are accompanied by dividend equivalent rights that will be payable in cash at the time of payout of the related shares.
