 - (2) On March 19, 2007, the Partnership converted 201,600 shares of Class B Common Stock into shares of Class A Common Stock on a one-for-one basis for no cost; accordingly, there was no applicable purchase or sale (109,099 shares represents Mr. Tyson's pro-rata interest).
 - (3) On March 20, 2007, the Partnership converted 251,400 shares of Class B Common Stock into shares of Class A Common Stock on a one-for-one basis for no cost; accordingly, there was no applicable purchase or sale (136,049 shares represents Mr. Tyson's pro-rata interest).
