The option, which provided for vesting in one-third increments on November 3, 2004, May 3, 2006 and May 3, 2007, was cancelled in (1) the merger with Brookdale Senior Living Inc. in exchange for a cash payment of \$128,479.50 representing the difference between the exercise price of the option and the market value of the underlying common stock on the effective date of the merger.
