Elliott Associates, L.P., through its subsidiary, Manchester Securities Corp., a New York corporation ("Manchester"), has an indirect pecuniary interest in the shares of common stock of BioDelivery Sciences International, Inc. ("BDSI"), owned by CDC IV, LLC ("CDC IV"). Manchester owns a majority of the equity interest of CDC IV (but not a controlling interest). On June 4, 2009, the manager of CDC IV delegated to Manchester all of the manager's rights and authority with respect to the investment decisions relating to the equity securities of BDSI owned by CDC IV.

(2) On June 17, 2009, CDC IV sold an aggregate of 100,000 shares of Common Stock of BDSI at an average gross price per share of \$6.4108. The individual trades made by CDC IV on June 17, 2009 are set forth on Exhibit 1(a) attached hereto.

(3) On June 18, 2009, CDC IV sold an aggregate of 63,391 shares of Common Stock of BDSI at an average gross price per share of \$6.5028. The individual trades made by CDC IV on June 18, 2009 are set forth on Exhibit 1(b) attached hereto.
