### Item 1. Security and Issuer.

The title of the class of security to which this statement relates is the Common Stock of Derma Sciences, Inc, whose principal executive offices are located at 214 Carnegie Center, Suite 100, Princeton, NJ 08540.

### Item 2. Identity and Background

This statement is filed by Peter E. Salas, a United States citizen with a business address at Dolphin Asset Management Corp., 129 East 17th Street, NY, NY 10003, as General Partner of Dolphin Offshore Partners, L.P. His present principal occupation is General Partner of Dolphin Offshore Partners, L.P. During the last five years, Mr. Salas has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors) nor been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction subjecting him to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, Federal or State securities laws or finding any violation with respect to such laws.

### Item 3. Source and Amount of Funds or Other Consideration

133,334 common shares and 146,668 warrants were purchased directly from the issuing company on August 10, 2000. 200,000 common shares were purchased directly from the issuing company on February 4, 2002.

### Item 4. Purpose of the Transaction

The shares and warrants were acquired for investment purposes only.

### Item 5. Interest in Securities of the Issuer

Mr. Salas is the beneficial owner of 333,334 common shares and 146.668 warrants.

### Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer

Mr. Salas has the exclusive right to vote the shares of Common Stock at any regular or special meetings of the shareholders of the Company and/or any actions in lieu of meetings or shareholder proceedings.
