Item 1. Security and Issuer.

The title of the class of security to which this statement relates is the Common Stock of First Look Media, Inc., whose principal executive offices are located at 8000 Sunset Boulevard, Los Angeles, California 90046.

Item 2. Identity and Background

This statement is filed by Peter E. Salas, a United States citizen with a business address at Dolphin Asset Management Corp., 129 East 17th Street, NY, NY 10003, as General Partner of Dolphin Offshore Partners, L.P. His present principal occupation is General Partner of Dolphin Offshore Partners, L.P. During the last five years, Mr. Salas has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors) nor been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction subjecting him to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, Federal or State securities laws or finding any violation with respect to such laws.

Item 3. Source and Amount of Funds or Other Consideration

An additional 562,527 common shares were purchased in a private transaction on October 8, 2002 with the working capital of Dolphin Offshore Partners, L.P.

Item 4. Purpose of the Transaction

The common shares were acquired for investment purposes only.

Item 5. Interest in Securities of the Issuer

Mr. Salas is the beneficial owner of 1,520,447 common shares.

Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer

Mr. Salas has the exclusive right to vote the shares of Common Stock at any regular or special meetings of the shareholders of the Company and/or any actions in lieu of meetings or shareholder proceedings.
