(AWM), the general partner of and investment adviser to Special Situations Cayman Fund, L.P. (Cayman). AWM also serves as the general partner of MGP Advisers Limited Partnership (MGP), the general partner of and investment adviser to Special Situations Fund III, L.P. (SSF3) and Special Situations Fund III QP, L.P.* (SSFQP). (SSF3, SSFQP and Cayman will hereafter be referred to as, the Funds). The principal business of each Fund is to invest in equity and equity-related securities and other securities of any kind or nature.

*Pursuant to that certain Exchange Tender Offer described in the Schedule TO-I of the Special Situations Fund III, L.P. (SSF3) as filed by SSF3 with

the Securities and Exchange Commission on November 17, 2005, SSF3 transferred the securities included in this Schedule 13D to Special Situations Fund III QP, L.P. (SSFQP) on December 31, 2005.
