A trust, settled by the reporting person and of which the reporting person is a beneficiary, is a partner of a partnership established by Brenthurst Private Equity II Limited ("Brenthurst"). In connection with the trust's withdrawal from Brenthurst, the reporting person transferred 25,001 shares of common stock to Brenthurst (which represented the shares previously acquired upon exercise of certain options which the reporting person held for the benefit of Brenthurst pursuant to certain arrangements).
