(1) Represents shares reacquired to satisfy tax withholding obligations in connection with the vesting of 4,158 shares of restricted stock granted to the Reporting Person on 4/1/13.

(2) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 10/1/14 and 1/48th per month thereafter.

(3) Each restricted stock unit represents a contingent right to receive one share of eBay's common stock.

Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.

The reporting person received 11,001 restricted stock units subject to a four-year vesting schedule, vesting 25% on 4/1/15 and 25% each year thereafter. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.

(7) The option grant is subject to a four-year vesting schedule, vesting 25% on 5/1/13 and 1/48th per month thereafter.

(8) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 10/1/13 and 1/48th per month thereafter.

Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.
