Item 8.01 Other Events

On February 4, 2013, Vectren Corporation (the "Company") announced that its subsidiary Vectren Utility Holdings, Inc. ("VUHI") will redeem all of its outstanding 6.25 percent Senior Monthly Notes due 2039. A copy of the press release containing more information about the redemption notice is attached as Exhibit 99.1 to this Current Report on Form 8-K.
