Portugal Telecom, SGPS S.A. ( PT ) informs that Telemar Norte Leste S.A. ( Telemar ) acting as a person closely related to Pedro Jereissati and Otávio Marques de Azevedo, non-executive directors of PT since 6 April 2011, as these PT directors are also directors of Telemar, communicated the following to PT:

On 19 April 2011, Telemar has acquired, on an OTC transaction, 35,860,500 PT shares, at a price of Euro 8.11 per share, subject to possible price adjustments. As a result of this acquisition, Telemar now holds a total of 62,755,860 shares, representing 7.0% of PT 's share capital and corresponding voting rights.

PT further informs that the abovementioned non-executive directors of PT do not own shares representing PT 's share capital and the corresponding voting rights.

This announcement is pursuant to the terms of article 248-B of the Portuguese Securities Code and of article 14 of the CMVM Regulation no. 5/2008.
