There were present or represented in the general meeting shareholders representing 44% of the voting share capital.

The proposal was approved by a majority of 97,81% of the votes present or represented and cast at the General Meeting.

The Chairman of the General Meeting of Shareholders did not allow the shareholder Telemar Norte Leste, S.A. to vote.
