This registration statement on Form S-8 is filed by WPX Energy, Inc., a Delaware corporation (the **Company**), to register an additional 750,000 shares of the Company's common stock for issuance under the WPX Energy, Inc. 2011 Employee Stock Purchase Plan, effective as of December 2, 2011, amended as of February 19, 2018 (the **Plan**). Accordingly, pursuant to General Instruction E to Form S-8, the Company incorporates by reference the contents of such registration statement on Form S-8 (Registration No. 333-178388), except as otherwise updated or modified by this registration statement.
