- (1) Grant of restricted stock into the Deferred Compensation Plan approved by the Compensation Committee of the Board of Directors for no consideration. Grants vest 30%, 30% and 40% over three years on the anniversary of the date of the grant.
  - (2) Company match in deferred compensation account deposited on 5/18/11. The company match vests 1/3 each December 31st over three years.
  - (3) Stock Appreciation Rights vest 30%, 30% and 40% over three years on the anniversary of the date of grant, have a five year term and were granted pursuant to the Range Resources 2005 Equity Plan.
