(1) Restricted Stock Units (RSUs) granted under the PG&E Corporation 2014 Long-Term Incentive Plan (LTIP). RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis. As described in the LTIP, RSUs vest upon the earliest of one year from the date of grant, the last day of the director's elected term, or a director's death, disability, or termination following a change in control.

(2) This total includes the acquisition of 98.05 RSUs on 7/15/14, 102.37 RSUs on 10/15/14, 82.07 RSUs on 1/15/15, and 69.66 RSUs on 4/15/15 pursuant to a dividend reinvestment feature of the LTIP.
