- (4) The price reported is the weighted average price of multiple transactions ranging from \$21.95 to \$22.60. The reporting person hereby undertakes to provide upon request to the SEC, the Issuer or a security holder of the Issuer the number of shares of Class A Common Stock and the prices at which the transactions were effected.
