ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT

On March 27, 2006, the Compensation Committee ("the Committee") of the Board of Directors of HEICO Corporation ("the Company") approved increases in the base salary of our Chief Executive Officer and three executive officers who were named in the Summary Compensation Table of the Company's proxy statement for our 2005 Annual Meeting of Shareholders (they are also expected to be named in the Summary Compensation Table of the Company's proxy statement for our 2006 Annual Meeting of Shareholders) effective March 27, 2006 by the following percentages: Laurans A. Mendelson, Chairman of the Board, President and Chief Executive Officer - 6.8%; Thomas S. Irwin, Executive Vice President and Chief Financial Officer - 7.8%; Eric A. Mendelson, President and Chief Executive Officer of HEICO Aerospace Holdings Corp. - 7.8%; and Victor H. Mendelson,

President and Chief Executive Officer of HEICO Electronic Technologies Corp and General Counsel - 7.8%.

Also on that date, the Committee approved an increase in the annual retainer received by Directors of the Company to \$75,000 effective May 1, 2006. The Directors are required to purchase shares of the Company's corporate common stock equivalent to one-half of the annual retainer.
