(1) On January 2, 2007, the Issuer entered into an agreement with George H.C. Lawrence (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 800 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").

(2) This figure includes 3,400 restricted shares of Class A Common Stock issued pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan. On January 2, 2007, restrictions applicable to a previously reported grant of 300 restricted shares of Class A Common Stock lapsed, resulting in the Reporting Person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.

(3) The Reporting Person is the direct beneficial owner of 37,406 shares of Class A Common Stock, including the 3,400 restricted shares referenced in footnote (2). He is the indirect beneficial owner of 2,600 shares of Class A Common Stock owned of record by the George H.C. Lawrence Money Purchase Plan of which the Reporting Person is the sole trustee.
