(1) All of the transactions reported on this Form 4 represent the reinvestment by Mr. Lusk's broker of dividends paid on ABM shares owned by Mr. Lusk in additional shares of ABM stock, which transactions were not reported by the broker to the issuer. Mr. Lusk has paid ABM the short-swing profits resulting from these transactions and has instructed his broker to cease reinvesting these dividends.
