## Explanation of Responses:

- (1) Units convert to Common Stock on a one-to-one basis upon vesting.
- (2) Grant vests in three equal installments on January 25, 2013, 2014 and 2015.  
Between 50% and 100% of the units will vest on January 25, 2015, if the average per-share closing price of the Company's common stock equals or exceeds a minimum threshold price of \$17.64 and a maximum target price of \$19.69 over any consecutive 30 trading days
- (3) between the grant date and the third anniversary of the date of grant. The actual number of units that vest, based on the average per-share closing price between the threshold and target prices shall be determined on a pro rata basis using straight line interpolation.
- (4) Grant vests on January 25, 2015, subject to the Company's attainment of pre-established financial performance goals.
- (5) Expiration date not applicable.
