(1) 6,373 Restricted Stock Units (Common Stock equivalents) were granted pursuant to the WD-40 Company 2007 Stock Incentive Plan. The Restricted Stock Units (RSUs) will be settled solely with Issuer Common Stock upon an annual vesting schedule as provided for in the Award Agreement for the RSUs as follows: 2,167 shares not later than November 15, 2013, 2,103 shares not later than November 15, 2014, and 2,103 shares not later than November 15, 2015.

(2) 6,373 Market Share Units (Common Stock equivalents) were granted pursuant to the 2007 Stock Incentive Plan. The Market Share Units (MSUs) will be settled solely with Issuer Common Stock upon performance vesting as provided for in the Award Agreement for the MSUs following a 3-year performance measurement period.

(3) Total includes 1,141,338 shares held in WD-40 Company Profit Sharing Plan (Company Stock Fund) account. Total also includes 17,519 Restricted Stock Units, of which 11,635 are subject to future vesting, 7,158 Performance Share Units, all of which are subject to future vesting, and 6,373 Market Share Units, all of which are subject to future vesting.
