- (1) Disposition of Performance Share Units (Common Stock equivalents) upon certified performance vesting of Performance Share Units (PSUs) awarded to the reporting person on October 11, 2011. 5,780 vested shares will be issued to the reporting person pursuant to the PSU Award Agreement, subject to withholding for taxes.
- (2) 4,571 Restricted Stock Units (Common Stock equivalents) were granted pursuant to the WD-40 Company 2007 Stock Incentive Plan. The Restricted Stock Units (RSUs) will be settled solely with Issuer Common Stock upon an annual vesting schedule as provided for in the Award Agreement for the RSUs as follows: 34% not later than November 15, 2014, 33% not later than November 15, 2015, and 33% not later than November 15, 2016.
- (3) 4,571 Market Share Units (Common Stock equivalents) were granted pursuant to the 2007 Stock Incentive Plan. The Market Share Units (MSUs) will be settled solely with Issuer Common Stock upon performance vesting as provided for in the Award Agreement for the MSUs following a 3-year performance measurement period.
- (4) Total includes 1167.658 shares held in WD-40 Company Profit Sharing Plan (Company Stock Fund) account. Total also includes 22,090 Restricted Stock Units, of which 16,206 are subject to future vesting, 10,944 Market Share Units, all of which are subject to future vesting, and 5,780 PSUs, all of which are vested.
