The Class B Voting Stock and options to acquire Class B Voting Stock are held for the benefit of Mr. James J. Cotter, Sr.'s grandchildren. The extent of any pecuniary interest in any Class A Non-Voting Stock to Ms. Cotter is dependent upon certain factors yet to be resolved. Accordingly, the extent of her pecuniary interest in the Class A Common Stock is not currently known.
