Investment description

· Linked to the EURO STOXX 50[®] Index.

Unlike ordinary debt securities, the securities do not pay interest or repay a fixed amount of principal at maturity.

Instead, the securities provide for a payment at maturity that may be greater than, equal to or less than the initial public offering price of the securities, depending on the performance of the Index from its Initial Index Level to its Final Index Level.

The payment at maturity will reflect the following terms:

o If the level of the Index increases:

You will receive the initial public offering price plus 170% participation in the upside performance of the Index of the initial public offering price

o If the level of the Index stays unchanged or decreases but the decrease is not more than 35%:

You will be repaid the initial public offering price

o If the level of the Index decreases by more than 35%:

You will receive less than the initial public offering price and will have 1-to-1 downside exposure to any decrease in the level of the Index in excess of 35%.
