Mr. Yaphe disclaims beneficial ownership of the shares held by such entities, other than to the extent of his pecuniary interest therein.
- (2) Represents restricted shares of the Issuer's common stock. The restricted stock was forfeited upon Mr. Yaphe's resignation as a director on May 10, 2007.
