Mr. Jobson is also a managing member of Tetra Capital Management, LLC, an affiliate of Delta Partners, LLC, and is deemed to have investment discretion over an additional 5,000 shares of the issuer. Tetra Capital Management, LLC is the investment manager for two private investment funds. The two entities are the actual owners of the 5,000 shares. Both reporting persons disclaim beneficial ownership in the shares reported herein except to the extent of their pecuniary interest.
