These 21,126 shares are not sold on the open market and become Revlon, Inc. treasury shares. Of the remaining 125,001 unvested restricted shares that Mr. Kretzman was granted on November 16, 2006, 62,500 will vest on November 16, 2008 and 62,501 will vest on November 16, 2009.
- (2) Of these 385,714 shares, 260,713 shares were vested, net of shares withheld to pay federal and state taxes due upon vesting, and 125,001 shares were not vested as of the date of this report.
