These shares were held indirectly under HP's 401(k) Plan as of 11/30/09. Fidelity Investments Institutional Services Company, Inc.

The 49.3299 dividend equivalent rights being reported reflect 49.3299 dividend equivalent rights at \$45.96 per RSU credited to the reporting person's account on 10/07/09.

(5) On 12/10/09 the Reporting Person was granted 32,109 restricted stock units ("RSUs"), 16,054 of which will vest on 12/10/10 and 16,055 which will vest on 12/10/11. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
