(1) 48,000 performance shares are scheduled to vest in two equal annual installments beginning 8/31/08; 67,500 performance shares are scheduled to vest in three equal annual installments beginning 8/31/08; 8,750 performance shares are scheduled to vest in two equal annual installments beginning 5/1/09; and 50,000 performance shares are scheduled to vest in four equal annual installments beginning 8/31/08 (all vesting is subject to continued employment).

(2) 50,000 shares became exercisable on each of 5/1/07 and 5/1/08; and 50,000 shares to become exercisable on each of 5/1/09 and 5/1/10, subject to continued employment.
