On February 16, 2010, NetLogic Microsystems Inc. declared a stock dividend, payable to all holders of record of common stock on March 5, 2010, of one share of common stock for each share of common stock outstanding. As a result, the reporting person received (1) 105,485 shares of common stock on March 19, 2010. At the same time, pursuant to anti-dilution provisions of NetLogic Microsystems' equity incentive plans, options for 50,000 shares of common stock held by the reporting person on March 19, 2010 became exercisable for 100,000 shares of common stock upon vesting.

(2) Restricted Stock Unit (RSU) award granted on July 21, 2010. Each RSU represents a contingent right to receive one share of the company's common stock once vested. The entire award vests on the date of NetLogic Microsystems' Annual Meeting of Stockholders on 2011, subject in all instances to the reporting person's continuous employment or consulting status with the company.
