(1) On July 23, 2014, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 5,250 of the 21,000 Performance Share Units granted to Mr. Pimentel on September 9, 2013. The 5,250 Ordinary Shares will vest on September 9, 2014, subject to the continuous service through such date.

(2) On July 23, 2014, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 6,000 of the 24,000 Performance Share Units granted to Mr. Pimentel on September 10, 2012. The 6,000 Ordinary Shares will vest on September 10, 2014, subject to the continuous service through such date.
