Transaction in Own Shares

The Company has today purchased 250,000 of its Ordinary Shares of US 20¢ each through JP Morgan Cazenove, in accordance with the authority granted by shareholders at the Company's Annual General Meeting on 11 April 2013.

The average price paid was 812.7962p per share.

The highest price paid was 814.50p per share and the lowest price paid was 809p per share.

The Company intends to hold these shares in Treasury.

Following the purchase of these shares and previous transactions which are yet to settle, the Company holds 31,441,773 of its shares in Treasury. The Company's issued share capital, with one voting right per share consists of 894,049,996 Ordinary Shares of US20¢ each. This is the figure which should be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure and Transparency Rules.
