Change in ADR Ratio and ADR Depositary  
24 September 2014

Smith & Nephew (LSE: SN, NYSE: SNN), the global medical technology business, announces an intended ratio change to its NYSE-listed American Depositary Receipt ("ADR") programme. The ratio will change from the current one ADR per five Ordinary Shares to one ADR per two Ordinary Shares. The anticipated effective date for the ratio change is 14 October 2014. There will be no change to the underlying Ordinary Shares.

To implement the change, ADR holders on the record at the close of business one business day prior to the ratio change taking effect will receive 2.5 ADRs for every one ADR held. Any resulting fractional ADRs will receive cash in lieu. The new ADRs are expected to be distributed on or around 14 October 2014. No action is required by ADR holders.

These changes to the ADR ratio will bring the ADR price broadly in line with the market average. Deutsche Bank has been appointed as the successor depositary bank for the ADR programme effective 1 October 2014.
