**ChipMOS REPORTS SEPTEMBER 2007 REVENUE**

**Hsinchu, Taiwan, October 17, 2007** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS) today reported its unaudited consolidated revenue for the month of September 2007.

Revenue for the month of September 2007 was NT\$2,040.1 million or US\$62.5 million, an increase of 2.5% from the month of August 2007 and an increase of 9.5% from the same period in 2006. On a quarterly basis, revenue for the third quarter of 2007 was NT\$5,939.5 million or US\$182.1 million, an increase of 1.8% from the second quarter of 2007 and an increase of 11.8% from the same period in 2006. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.62 against US\$1.00 as of September 28, 2007.)
