On February 10, 2009, Manitex International, Inc. (the Company) issued a press release announcing \$6.6 million of new orders (the Press Release). Additionally, the press release provided an update on restructuring activities commenced in the third quarter of 2008. Specifically, since the end of the third quarter 2008, Manitex International, Inc. has implemented across the board cost reduction activities that we estimate will yield approximately \$5 million in annual expense reductions.
