**Item 8.01. Other Events.**

On August 3, 2010, Petrohawk Energy Corporation (the Company) issued a press release announcing that it intends to commence a private offering to eligible purchasers of approximately \$825 million aggregate principal amount of senior notes due 2018 (the Notes). Proceeds of the offering are expected to be used to purchase the Company's outstanding approximately \$769 million aggregate principal amount of 9 1/8% senior notes due 2013 pursuant to a tender offer and, to the extent there are net proceeds remaining, for general corporate purposes.

The Notes have not been registered under the Securities Act of 1933 (the Securities Act) or applicable state securities laws and may not be offered or sold in the United States absent registration or an applicable exemption from the registration requirements of the Securities Act and applicable state laws. The Notes may be resold by the initial purchasers pursuant to Rule 144A and Regulation S under the Securities Act.
