Additionally, Mr. Satterfield has limited powers of attorney for voting and disposition purposes with respect to the following shares: A.G. Family L.P. (320,000 shares); David A. Satterfield (10,000 shares); Jeanette Satterfield Kaiser (35,000 shares); and Richard W. Kaiser (20,000 shares). These individuals and entities have the right to receive or the power to direct the receipt of the proceeds from the sale of their respective shares.
