- (6) On February 13, 2003, the reporting person was granted an option to purchase 20,000 shares of FPL Group, Inc. common stock with an exercise price of \$55.12 per share. The option (i) vests as to 6,667 shares (on a cumulative basis) on each anniversary of the date of grant beginning on the first anniversary of the date of grant and (ii) expires on February 13, 2013.

- (7) On February 12, 2004, the reporting person was granted an option to purchase 20,000 shares of FPL Group, Inc. common stock with an exercise price of \$64.92 per share. The option (i) vests as to 6,667 shares (on a cumulative basis) on each anniversary of the date of grant beginning on the first anniversary of the date of grant and (ii) expires on February 12, 2014.

- (8) The option shall vest as to 3,334 shares (on a cumulative basis) on each anniversary of the date of grant beginning on the first anniversary of the date of grant.
