- This grant was made pursuant to the issuer's non-employee director compensation policy that became effective on May 15, 2008, the date of the issuer's 2008 annual meeting of stockholders. As a continuing director, the Reporting Person was awarded a number of shares equal to \$80,000 divided by \$6.99, the closing price of the issuer's common stock on the date of the grant. The shares underlying this restricted stock award will vest in full on the earlier of (i) May 15, 2009 or (ii) the date immediately preceding the date of the issuer's 2009 annual meeting of stockholders.
- (1) Shares are held by the Guleri Family Trust UTD dated April 7, 1999. The Reporting Person is a trustee and beneficiary of the Guleri Trust.
 - (2) Consists of 1,101,495 shares held by Sierra Ventures VIII-A, L.P. ("Sierra VIII-A") and 10,718 shares held by Sierra Ventures VIII-B, L.P. ("Sierra VIII-B"). Sierra Ventures Associates VIII, LLC ("SVA VIII") is the general partner of Sierra VIII-A and Sierra VIII-B and possesses voting and dispositive power over the shares held by Sierra VIII-A and Sierra VIII-B. The Reporting Person is a managing member of SVA VIII. The Reporting Person disclaims beneficial ownership of the shares held by Sierra VIII-A and Sierra VIII-B, except
