- (1) Quarterly payment in shares of Anthracite Capital, Inc. (the "Company") Common Stock of \$75,000 annual retainer for reporting person as a director. The quarterly payment is made on the eleventh day of the applicable Window Period (as defined below) or as promptly as practicable thereafter so long as the reporting person is still serving as a director on the date of such payment.
