- (1) These restricted stock units were granted under the Endo Pharmaceuticals 2007 Stock Incentive Plan and vest ratably over a two-year period, 50% on March 12, 2010 and 50% on March 12, 2011, and will be settled in common stock. Pursuant to the Endo Pharmaceuticals Directors Deferred Compensation Plan (the Plan), Mr. Spengler has elected to defer receipt of these RSUs.
- (2) These securities were granted to Mr. Spengler in consideration of his services on the Endo Pharmaceuticals Holdings Inc. Board of Directors.
- (3) This number represents 6,136 restricted stock units (including these 4,018 restricted stock units), none of which are fully vested. Mr. Spengler's beneficial ownership disclosed in this table excludes all shares held by Mr. Spengler indirectly, including shares underlying stock options.
