Pursuant to the Endo Pharmaceuticals Directors Stock Election Plan, on November 30, 2010, Mr. Spengler elected to receive 100% of his 2011 cash retainer fees and 100% of his 2011 meeting fees in Endo common stock. At the time that the retainer and meeting fees would otherwise have been payable, the number of shares of Endo common stock are fixed and are reported as of such date on Table I as an acquisition of securities. These cash retainer and meeting fees are payable to Mr. Spengler in consideration of his services on the Endo Pharmaceuticals Holdings Inc. Board of Directors, Audit Committee and Compensation Committee for the third quarter 2011 meetings and the third quarter 2011 retainer. Under the Endo Pharmaceuticals Directors Deferred Compensation Plan, also on November 30, 2010, Mr. Spengler elected to defer receipt of all of these shares.

This number represents (i) 5,677 restricted stock units and (ii) 15,679 shares of common stock, receipt of 13,561 shares of which has been deferred under the Endo Pharmaceuticals Directors Deferred Compensation Plan. Mr. Spengler's beneficial ownership disclosed in this table excludes all shares held by Mr. Spengler indirectly, including shares underlying stock options.
