Common Shares were to be earned based on the level of achievement of specified performance objectives over the three-year period ended May 31, 2014. On June 24, 2014, the Compensation Committee of the Company's Board of Directors met and approved the payout of the reported common shares based on the performance of the Company for the three year period ended May 31, 2014.
- (2) Represents shares withheld in order to satisfy the reporting person's tax withholding obligation. Form 4 filed on 6-26-14 reported an incorrect number of shares withheld. This number reflects the accurate number of shares withheld.
