- (1) The transaction reported was effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on August 21, 2014.
- (2) Balance reflects dividend reinvestment shares purchased on September 20, 2014.
- (3) Balance reflects shares pertaining to the September 20, 2014 dividend, and an earnings adjustment on September 30, 2014 under the Company's Employee Stock Ownership Plan.
- (4) The option vests in four equal annual installments beginning on the exercisable date.
- (5) Performance stock rights represent the right to receive shares of common stock of the Company, in the event certain performance goals are satisfied.
