- This amount includes 96,867 shares held in escrow pursuant to the Corporation's 2008 Long Term Incentive Plan. The reporting person
- (1) has only voting power of these shares until the lapsing of the period set by the Committee administering the Plan at which time the shares plus accrued dividends will be delivered to the reporting person if he is still an employee of the Corporation.
 - (2) Each depository share represents 1/20 of a share of the Corporation's 8% Series A Mandatory Convertible Preferred Stock.
 - (3) 200,000 depository shares generally convert into a minimum of 218,220 shares of the Corporation's common stock and a maximum of 256,420 shares of common stock depending on the date of conversion and the market value of the Corporation's Common Stock, subject to certain adjustments. The depository shares mandatorily convert into common stock on or about February 1, 2019.
