If receipt of shares upon vesting was not deferred, RSUs convert to unrestricted Nordson Common shares on a one-for-one basis.

(4) Restricted share units acquired through dividend unit accruals pursuant to the 2012 Stock Incentive and Award Plan.

(5) Share equivalent units accrued through Nordson's Directors' Deferred Compensation Sub-Plan. At time of distribution, share equivalent units convert to common shares on a one-for-one basis. Distribution is not permissible until participant ceases to be a director.

(6) Share equivalent units acquired through dividend payments.
