When receipt is not deferred, RSUs convert to unrestricted Nordson Common Shares on a one-for-one basis on the vesting date.
- (2) Share equivalent units accrued through Nordson's Directors' Deferred Compensation Plan. At time of distribution, share equivalent units convert to common shares on a one-for-one basis. Distribution is not permissible until participant ceases to be a director.
