- (1) Award of performance share units (PSUs) earned for the performance period ended October 31, 2014. The PSUs will convert to common shares on a one-for-one basis on the settlement date.
- Reporting person elected to defer the receipt of a portion of the PSUs awarded and instead will be credited on the settlement date share equivalent units under the Amended and Restated 2005 Deferred Compensation Plan.
