- (1) Under the Plan of Arrangement, the reporting person's 100% cash election was prorated at the rate of approximately 86% of cash elected, resulting in the acquisition of 52 shares of Marathon common stock.
  - (2) On June 18, 2007, the common stock of Marathon Oil Corporation split 2-for-1 for holders of record on May 23, 2007, resulting in the reporting person's ownership of 76,722 additional shares of common stock.
