Grant by Tracinda Corporation to the reporting person, who is an employee of Tracinda Corporation, of stock appreciation rights to receive cash with respect to 400,000 shares of common stock of MGM MIRAGE held by Tracinda Corporation as partial compensation for services to Tracinda Corporation. Vesting calls for 25% per year on February 1, 2008, 2009, 2010 and 2011. Ownership of the common stock is retained directly by Tracinda Corporation and indirectly by Kirk Kerkorian who owns all of the outstanding shares of common stock of Tracinda Corporation.
